ERRATA ORDER


AND NOW, it is hereby

- I) Rule 322.1 (j) is hereby amended to change the parenthetical notation in the last sentence, following "five" from "(3)" to "(5)".


- (II) Rule 322.7 (c) is hereby amended to add at the end of the paragraph, "and a copy to the magistrate who made the decision."


